- Starting last contract (3 yrs ago) rates CDC required to pay employees went up due to new adherence to federal standards (onsite)
 - Contractor (Bright Horizons) losing money
- BH wouldn't renew/extend contract without consessions:
 Bob (alone?) allowed the lunch concession to ensure 1 more year
- New contract will be RFP'd in a year
- Through Christina Swinson/BWIS, contacted group of concerned parents—ascertaining what kind of help they'd like
 - main focus: have them involved in RFP process
