As a group, our main role is to communicate important issues to lab management, and vice-versa. We'll meet once a month currently set for 2nd Friday of each month from 2-4pm. We'll provide a doodle form towards the end of the year to find a more globally acceptable time so that UEC members from Asia can join and to avoid the current conflict with the Nuclear Seminars in BNL.

We are organized within 5 working groups. These are: SAS, FPP, MCO, Quality of Life, and Diversity. ## Meetings:

The two meetings that UEC organizes are AUM and DNP Open Form and this year they will be chaired by Ron Belmont.

The date of the Open Forum during upcoming DNP meeting is expected to be finalized next week after consultation with Gail, the conference coordinator of DNP. It is currently penciled in for Oct 15th. Due to the short duration of the DNP meeting unfortunately this time conflicts with the women in physics dinner. One main speaker will be identified and invited for the open form and users will be encouraged to give input for the open form. Light snacks are expected to be served during the meeting.

AUM meeting possible weeks are: June 9-12th or June 16th-19th. The priority is the June 9th-12th to

highlight the 20th anniversary of RHIC running. First collisions were at 9 pm on June 12th in 2000 so the theme of AUM this year will be the 20th anniversary of RHIC running. To make it a special event, we will start thinking about inviting special guests, for example founding spokespeople of RHIC experiments, politicians and or ADL who made RHIC a reality. In order to invite congressperson or people we need to communicate with David Manning who has previously helped inviting Rush Holt to AUM during the 2015 AUM. Communicate with BNL management to make this event even more special such as possibly fireworks at 9 pm on the 12th or a party to bring the community together. Keep ADL in the loop for his help, feedback and possible access to media funds.

UEC members' homework is to check the schedules to ensure that June 9th-12th is not going to have conflicting meetings before finalizing we finalize the AUM for that week.

## FPP:

Nuclear Physics DC Days have been very influential. Users will be again invited to participate this year. Users are kindly asked to provide non-governmental email address. Kelly will investigate if listservs can be used to collect non-governmental email addresses of interested users to ensure full communication. Communicate with the users the importance of where they sign up from, I,.e. their zip codes to maximize number of meetings with underrepresented states. If possible, communicate with other UEC chairs to ensure key states will have meetings with a delegation independent of whether they have constituents or not.

## Quality of Life:

New catering company took over food services in BNL as of Aug 9th. Some questions are raised regarding the services that they provide. While the food quality appears to be similar to previous catering company, it appears to be they are not environmentally friendly in the sense that only disposable cutlery and to go boxes are used. Maybe this is due to the adjustment period. Trash also apparently not collected fast enough which were brought up by users to various members of the UEC. Kathy will look into the trash collection and Cutlery issue further. It is also unclear to users the implication of apparent protests of previous employees. It was mentioned that the BNL employees received a notification about this and the question of if such statements need to be given to all users. It was unclear if such a statement is useful since not all active users are present in BNL but maybe this can be blogged.
