Collaboration codes of conduct

Current action items **NO DEVELOPMENTS**

- Will have a representative on BNL CoC committee
- Identified test subjects to take BNL's CoC investigation training
- Need to come up with outline for what record keeping for CoC complaints should look like
 - Note that records can be accessed by a FOIA request → targets of complaints should be allowed to leave an official rebuttal in the record
 - Complete record should include complaint, any records of evidence, whether some type of investigation was done, note about any action by collaboration in response, any rebuttal statement (with a note that this is not a actual finding)
 - Need members of an experimental DE&I committee to be able to access & query them. Access could be restricted to specific queries, as long as someone can answer the questions we have. Could be questions like, "Has there ever been a complaint about —?"
 - Need to be able to compile statistics on types of complaints and responses. Need to be able to look for trends.
 - Lab and experiment should agree on what the terms of accessing reports should be. Should be serious consequences for misusing this information or defying these terms.
