- All individuals who have been identified as a close contact of someone with COVID-19 but are asymptomatic can continue to work, but must wear a high-quality mask
- 50-person limit on internal (BSA) meetings has been removed.
- Lab visitors and guests are not required to provide vaccination information nor provide proof of a negative COVID-19 test
- Face coverings are no longer required on the Brookhaven Lab site or within Lab buildings, facilities, and vehicles, regardless of an individual's vaccination status.
- Social distancing is no longer required but is encouraged
